Our mission.

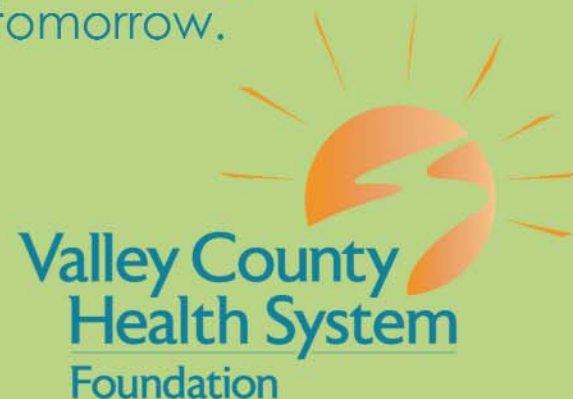

How can I donate to the Foundation?

CASH

Cash contributions may be made as an outright gift or may be pledged over a specified period of time.

STOCKS AND BONDS

A gift of securities may provide an enhanced tax advantage while providing significant support to Valley County Health System now and in the future.

MEMORIAL AND TRIBUTE GIFTS

The Foundation gratefully accepts memorial and tribute gifts in honor of loved ones and others who have made a difference in your life.

BEQUESTS

Donors make a powerful statement in support of Valley County Health System's work when they name the Foundation as a beneficiary in their wills.

CHARITABLE GIFT ANNUITIES

A charitable trust or annuity can be established to provide immediate benefits to the donor and, at the same time, the Foundation.

REAL ESTATE

The gift of land or a house can provide an enhanced tax advantage for donors and their heirs.

PERSONAL PROPERTY

Items such as art or vehicles that have an appraised value may also be donated to the Foundation.

LIFE INSURANCE

In most cases, this deduction is equal to the cost of the policy. You can either purchase a new policy or donate a policy that you currently own but no longer need.
